**IV. NTESPA Contract Approval**

Mr. Goers reviewed the Agreement with the New Trier Education Support Professionals Association. The new Four (4) Year Agreement will go into effect retroactively to July 1, 2012. The settlement for the four years included a percentage salary increase of 2.16% inclusive of the step increase in year one, 3.01% in year two and the final two years at the 2012 and 2013 CPI. Concessions were also made in insurance and retirement benefits. Board members applauded Mr. Goers and Mr. George Sanders, Director of Human Resources, as well as Board representative Lori Goldstein for the successful negotiations. Mr. Goers responded to Board members' questions. Mr. Myefski moved and Mr. Fischer seconded the motion that the Board ratify the Collective Bargaining Agreement between the New Trier Township High School District 203 and the New Trier Education Support Professionals Association for School Years 2012-13 through 2015-16. Upon a roll call vote being taken, the members voted as follows:
