- Must have piano accompanist playing orchestral accompaniment at audition
- Strongly recommend that your selection is memorized
- Your scheduled audition will take place at the Winnetka Campus between 6:00PM and 9:00PM on **Wednesday, January 10, 2018**
- Your whole selection may not be heard by adjudicators at the competition, they may choose to hear portions of your selection because of time constraints (be prepared to perform the whole movement)
- Application deadline is **Wednesday, December 12, 2018**
- A financial cost for rental/purchase of score and parts may be assessed of the winner
